### Job Purpose:

The job holder will be responsible for creating technical drawings and other relevant documents based on given specifications and calculations.

### Reporting Responsibilities

The job holder is responsible to the designated supervisor

### Area of Deployment:

Department of Building Services

### Key Duties and Responsibilities:

- i. Preparing draft technical drawings according to the given specifications;
- ii. Detailing of architectural and engineering plans;
- iii. Translating the architect and engineers rough sketches;

- iv. Carryout site measurements to allow designs to be done and drawings production;
- v. Indicating dimensions and materials for new or existing structures being modified;
- vi. Preparing multiple versions of designs for review;
- vii. Compiling data and specifications sheets;
- viii. Revising drawings and layouts to accommodate changes and enhancements; and
- ix. Incorporating safety procedures and issues in installation and construction drawing.
